9. MORTGAGE RIDER

The Rider, dated the 28th day of February amends the Mortgage of even date by and between Bert D. Caudle, Jr. and wife, Ila Dean Caudle , the Mortgagor, and Colonial Mortgage Company, the Mortgagee, as follows:

1. In Paragraph one (1), the sentence which reads as follows is deleted:

"Privilege is reserved to pay the debt in whole, or in any amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity: Provided, however, that written notice is given at least thirty (30) days prior to prepayment."

2. Paragraph one (1) is amended by the addition of the following:

"Privilege is reserved to pay the debt, in whole or in part, on any installment due date."

- 3. Subsection (a) of Paragraph two (2) is deleted.
- 4. Subsection (c)(I) of Paragraph two (2) is deleted.
- 5. In the third sentence of Paragraph three (3) the words "all payments made under the provisions of (a) Paragraph two (2) hereof which the Mortgagee has not become obligated to pay to the Secretary of Housing and Urban Development and" are deleted.
- 6. The fourth sentence of Paragraph three (3) is amended by the insertion of a period after "...then remaining unpaid under said Note" and deletion of the remainder of the sentence.
- 7. Paragraph sixteen (16) is amended by the addition of the following:

"This option may not be exercised when the ineligibility for insurance under the National Housing Act is due to the Mortgagee's failure to remit the mortgage insurance premium to the Department of Housing and Urban Development."
