LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that the undersigned, Charter National Life Insurance Company ("Charter"), 8301 Maryland Avenue, Clayton, Missouri, does hereby make, constitute and appoint Zeddie Andrews, Vice-President or any Vice-President of City Finance Company of Alabama, Inc.

to act singly or jointly as its true and lawful attorneys-in-fact for it and in its name, place and stead on its behalf and for its use and benefit, authorize them:


1. To direct the recordation of assignments of deeds of trust that have been conveyed by City Finance Company of Alabama, Inc.
