CERTIFICATE OF LIMITED PARTNERSHIP

- III. The principal place of business of the Partnership shall be located at 1031 21st Street South, Birmingham, Alabama, 35205, or any such other place as the General Partners may from time and at any time designate; and the agent of the Partnership designated to accept Service of Process upon the Partnership is John B. Davis, Jr., at the address noted above.

- IV. The name and place of residence of each member of the Partnership, general and limited partners being respectively designated, is shown in Exhibit A attached hereto and incorporated herein by reference.
- V. The amount of cash or property to be contributed by each General and Limited Partner to the capital of the Partnership is described on Exhibit A attached hereto.
- VI. The capital contributions to the Partnership noted in paragraph V and set forth in Exhibit A hereof are to be made on or prior to December 31.
- VII. No Limited Partner has the right, without the written consent of the General Partners, to substitute an assignee as Limited Partner in his place. In the event such consent is given, the transferring Limited Partner and his transferee must execute such instruments as the General Partners deem necessary or desirable; such transferee must accept and agree in writing to be bound by all of the terms and provisions of the Partnership Agreement; and such transferee must pay all reasonable expenses connected with such substitution.

VIII. No time has been agreed upon when a Partner may terminate his membership in the Partnership or when the capital contribution of any Limited Partner is to be returned, except upon dissolution of the Partnership.

- IX. No Partner is given priority over other Partners as to return of contributions or as to compensation by way of income, nor is any Partner entitled to receive distributions of property from the Partnership except as the General Partners, in their sole discretion, may determine.
- X. The Partnership is to be dissolved and its affairs wound up upon the expiration of the term of the Partnership or upon the sale of all of the Partnership's assets.
- XI. In the event of the death, retirement, insanity, with-drawal, dissolution, assignment for the benefit of creditors or adjudication of bankruptcy of either General Partner, the Limited Partners may but are not required to elect a substitute General Partner to jointly manage and continue the business of the Partnership with the other General Partner.
