KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of \$1.00 (One Dollar and 00/100-----) and other valuable considerations to the undersigned in hand paid by the City of Pelham, a municipal corporation, the receipt whereof is hereby acknowledged, I (we) _____ hereby grant, bargain, sell, and convey to the said City of Pelham an easement and right-of-way for the purpose of constructing, reconstructing, maintaining and repairing a Sanitary sewer, together with all necessary rights of access, ingress and egress thereto and therefrom, in, over, under and along the following described strip of land situated in the City of Pelham, Shelby County, Alabama:

A twenty (20) foot wide parcel of land being ten (10) feet each side of the following described line:

Commence at the Northeast Corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 36, Township 19 South, Range 3 West, thence Southerly along the East line of said $\frac{1}{4}$ Section to the South Right-of-Way line of the Old (abandoned) Right-of-Way of the Acton Branch Railroad thence run 105.61 feet (a width of 10.51 feet) along the north property line of Chenbone Land number one which is the old (abandoned) Right-of-Way of the Acton Branch Railroad to a point of termination, on the west Right-of-Way line of the Old Montgomery Highway.

TO HAVE AND TO HOLD the said easement and right-of-way hereinbefore granted to the said City of Pelham, its successors and assigns forever, for the purpose above mentioned and for no other purpose.
