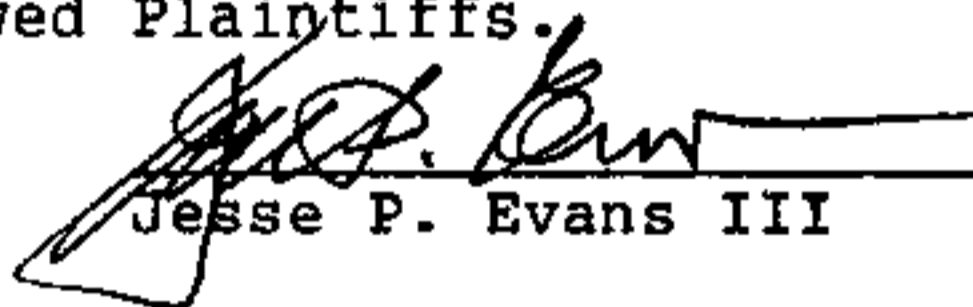
This action is pending in the Circuit Court of Jefferson County and is styled as set out above.
