KNOW ALL MEN BY THESE PRESENTS: That Whereas,

Timothy K. O'Brien, an unmarried man,

(hereinafter called "Mortgagors", whether one or more) are justly indebted, to
APCO EMPLOYEES CREDIT UNION

(hereinafter called "Mortgagee", whether one or more), in the sum
of Twenty Eight Thousand Eight Hundred and no/100----- Dollars
(\$ 28,800.00), evidenced by one promissory installment note bearing even date
herewith with interest at the rate of 9.6 percent per annum from date
and payable in 83 monthly installments of \$472.36 each, and one final
installment of \$439.64, the first installment being due and payable on
February 27, 1987, after date hereof, and one such remaining installment
shall be due on the same day of month thereafter until the entire indebted-
ness evidenced hereby shall have been fully paid.

And Whereas, Mortgagors agreed, in incurring said indebtedness, that this mortgage should be given to secure the prompt
payment thereof.

NOW THEREFORE, in consideration of the premises, said Mortgagors,

and all others executing this mortgage, do hereby grant, bargain, sell and convey unto the Mortgagee the following described
real estate, situated in Shelby County, State of Alabama, to-wit:

A part of the W $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 25, Township 19 South, Range 1 West,
described as beginning at the SE corner of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section
25, and run South 660 feet; thence run West 660 feet to point of beginning
of tract herein described; thence continue West 247 $\frac{1}{2}$ feet; thence run North
to the South right of way line of Florida Short Route Highway; thence run
Northeast along said right of way to a point which is 660 feet West of the
East line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$; such point being North of the point of
beginning; thence run South to the point of beginning.

LESS AND EXCEPT the following: Part of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 25,
Township 19 South, Range 1 West of Huntsville Meridian more particularly
described as follows: Begin at the NW corner of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section
25, and run South along the West side of said section a distance of
1034.39 feet to the South right of way of Highway 280, thence run Northeast
along the South right of way a distance of 439.9 feet to the point of
beginning, thence run North 69 degrees 40 minutes East for 100 feet,
thence South 466 feet, thence South 69 degrees 40 minutes West for 100
feet, thence North for 466 feet to the point of beginning. Situated
in Shelby County, Alabama.

NON ASSUMPTION AND TRANSFER CLAUSE:

If all or any part of the property or an interest therein is sold or
transferred by Borrower(s) without Lender's prior written consent, Lender
may, at Lender's option, declare all the sums secured by this mortgage to
be immediately due and payable and subject to any remedies as outlined
herein.

Said property is warranted free from all incumbrances and against any adverse claims, except as stated above.

To Have And To Hold the above granted property unto the said Mortgagee, Mortgagee's successors, heirs, and assigns forever; and for the purpose of further securing the payment of said indebtedness, the undersigned agrees to pay all taxes or assessments when imposed legally upon said premises, and should default be made in the payment of same, the said Mortgagee may at Mortgagee's option pay off the same; and to further secure said indebtedness, first above named undersigned agrees to keep the improvements on said real estate insured against loss or damage by fire, lightning and tornado for the fair and reasonable insurable value thereof, in companies satisfactory to the Mortgagee, with loss, if any, payable to said Mortgagee, as Mortgagee's interest may appear, and to promptly deliver said policies, or any renewal of said policies to said Mortgagee; and if undersigned fail to keep said property insured as above specified, or fail to deliver said insurance policies to said Mortgagee, then the said Mortgagee, or assigns, may at Mortgagee's option insure said property for said sum, for Mortgagee's own benefit, the policy if collected, to be credited on said indebtedness, less cost of collecting same; all amounts so expended by said Mortgagee for taxes, assessments or insurance, shall become a debt to said Mortgagee or assigns, additional to the debt hereby specially secured, and shall be covered by this Mortgage, and bear interest from date of payment by said Mortgagee, or assigns, and be at once due and payable.

Upon condition, however, that if the said Mortgagor pays said indebtedness, and reimburses said Mortgagee or assigns for any amounts Mortgagees may have expended for taxes, assessments, and insurance, and interest thereon, then this conveyance to be null and void; but should default be made in the payment of any sum expended by the said Mortgagee or assigns, or should said indebtedness hereby secured, or any part thereof, or the interest thereon, remain unpaid at maturity, or should the interest of said Mortgagee or assigns in said property become endangered by reason of the enforcement of any prior lien or incumbrance thereon, so as to endanger the debt hereby secured, then in any one of said events, the whole of said indebtedness hereby secured shall at once become due and payable, and this mortgage be subject to foreclosure as now provided by law in case of past due mortgages, and the said Mortgagee, agents or assigns, shall be authorized to take possession of the premises hereby conveyed, and with or without first taking possession, after giving twenty-one days' notice, by publishing once a week for three consecutive weeks, the time, place and terms of sale, by publication in some newspaper published in said County and State, sell the same in lots or parcels or en masse as Mortgagee, agents or assigns deem best, in front of the Court House door of said County, (or the division thereof) where said property is located, at public outcry, to the highest bidder for cash, and apply the proceeds of the sale: First, to the expense of advertising, selling and conveying, including a reasonable attorney's fee; Second, to the payment of any amounts that may have been expended, or that it may then be necessary to expend, in paying insurance, taxes, or other incumbrances, with interest thereon; Third, to the payment of said indebtedness in full, whether the same shall or shall not have fully matured at the date of said sale, but no interest shall be collected beyond the day of sale; and Fourth, the balance, if any, to be turned over to the said Mortgagor and undersigned further agree that said Mortgagee, agents or assigns may bid at said sale and purchase said property, if the highest bidder therefor; and undersigned further agree to pay a reasonable attorney's fee to said Mortgagee or assigns, for the foreclosure of this mortgage in Chancery, should the same be so foreclosed, said fee to be a part of the debt hereby secured.
