VERIFIED STATEMENT OF LIEN

Comes All American Carpets, Inc., a corporation, and hereby files this statement in writing, verified by the oath of Harry Dorough, Jr., as President of All American Carpets, Inc., a corporation, who has personal knowledge of the facts herein set forth:

That All American Carpets, Inc., a corporation, claims a lien upon the hereinafter described real estate situated in Shelby County, Alabama, which is located in the Lacoosa Estates subdivision on Lay Lake and which real estate is outside the limits of any municipality. This lien is claimed specifically against the newly constructed dwelling house of Joseph Barrett, Jr. and Faye G. Barrett and the land surrounding such dwelling house and contiguous thereto, all of which property is described as follows, to-wit:
