ARTICLES OF INCORPORATION

OF

THE DOCTOR'S OFFICE, P.C.

FIRST: The name of the Corporation is The Doctor's Office, P.C. The Corporation is organized pursuant to the Revised Alabama Professional Corporation Act.

SECOND: The Corporation shall have perpetual duration.

THIRD: The address of its registered office in the State of Alabama and name of its registered agent at such address is Joseph D. Meloni, Cahaba Medical Arts Building, Suite D, 5420 Highway 280 East, Birmingham, Alabama 35094.

FOURTH: The nature of the business or purposes to be conducted or promoted are:

- (a) To engage in any lawful act or activity for which corporations may be organized under the Revised Alabama Professional Corporation Act.
 - (b) To engage in professional medical services.

FIFTH: The total number of shares of stock which the Corporation shall have authority to issue is 1,000 shares, consisting of 1,000 shares of Common Stock of the par value of \$.01 per share.
