This release shall not be construed to waive or in any manner affect or invalidate the lien of the Mortgage upon the residue of the real property therein described.

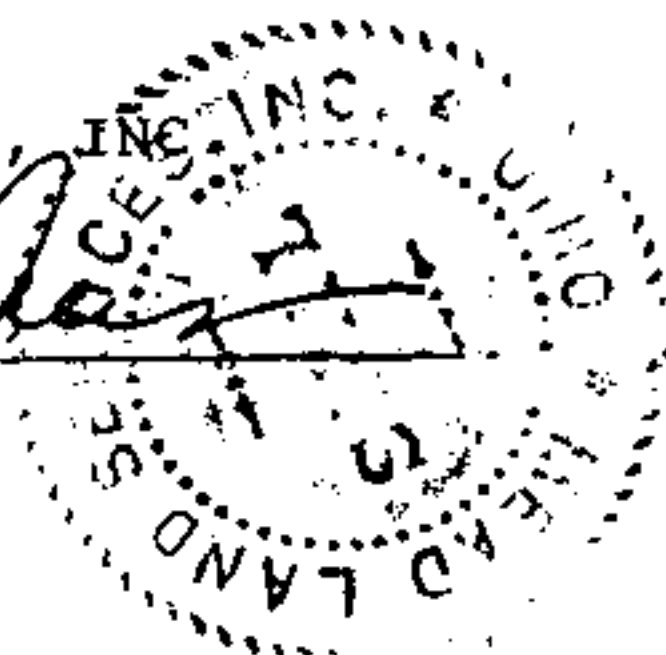
