KNOW ALL MEN BY THESE PRESENTS, That, Whereas, by decrees rendered by the Probate Court of Shelby County, Alabama, in the case of Joy Willis and Benjie Willis, minors, by their guardian, Joyce Willis, Case Nos. 26-180 and 26-181, on the 7th day of May, 1987, and in the case of Dawn Willis, a minor, by her guardian, Jean Willis Dawson, Case No. 26-182, on the 7th day of May, 1987, Joyce Willis as Guardian of Joy Willis and Benjie Willis, and Jean Willis Dawson as Guardian of Dawn Willis, were ordered and directed to make a conveyance of their respective wards' interests in the following described real estate: In consideration of the sum of \$29,000.00 Dollars:

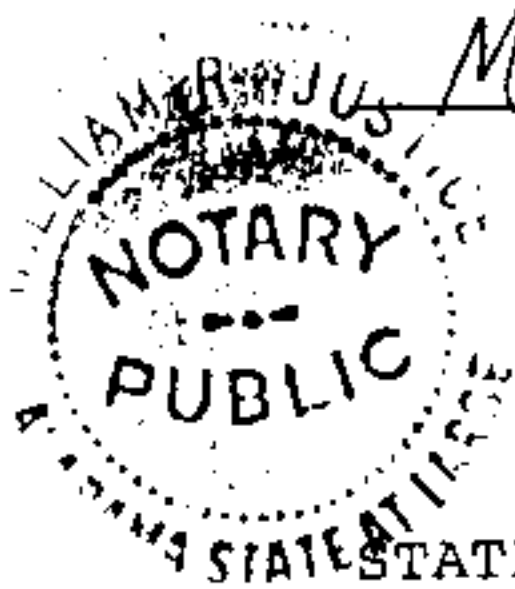
