(\$1.00) and other good and valuable consideration, in hand paid by the City of Pelham, Alabama, a municipal corporation, to the undersigned grantor(s), the receipt whereof is hereby acknowledged, I (we) the undersigned do hereby grant, bargain, sell and convey to the City of Pelham, Alabama an easement granting unto the City of Pelham, Alabama the full and absolute right to enter upon and to cut, grade, remove dirt, to store material upon and/or any other procedure required to complete the construction of a sanitary sewer line and all related appurtenances adjacent to the hereinafter described portion of land, all of which rights are hereby acknowledged by the grantor(s)

The easement hereby granted shall be temporary, the duration of which shall be for a period of thirty days (30) after the completion of said sanitary sewer line and in no event shall the period exceed one hundred and twenty (120) days after the completion of the said sanitary sewer, said time period to begin with the completion of said sewer, said property being situated in the City of Pelham, Alabama and described as follows:
