NOTICE OF PENDING ACTION

A strip of land thirty (30) feet in width which lies within the Northeast Quarter of the Southwest Quarter (NE 1/4 of SW 1/4) of Section 5, Township 21 South, Range 2 West, Shelby County, Alabama.

To reach a point of beginning, commence at the Northwest corner of the Northeast Quarter of the Southwest Quarter; thence run East along the North line 246.0 feet to a point, such point being the point of beginning of said thirty (30) foot strip; therefrom the strip lies 15 feet each side of a centerline and the continuations thereof, which begins at such point and turns an angle to the right of 110 degrees 21' and runs South 24 degrees 21' West a distance of 284.9 feet to a point, such point being called Point "A" for reference hereinafter; thence turn an angle to the left of 98 degrees 35' and run South 74 degrees 14' East 166.4 feet to a point; such point being called Point "B" for reference hereinafter; thence turn an angle to the right of 39 degrees 5' and run South 35 degrees 9' East a distance of 157.08 feet to a point, such point being called Point "C" for reference hereinafter; thence turn an angle to the left of 12 degrees 38' and run South 47 degrees 47' East a distance of 186.5 feet to a point, such point being called Point "D" for reference hereinafter; thence turn an angle to the right of 36 degrees 32' and run South 11 degrees 15' East a distance of 171.1 feet to a point, such point being called Point "E" for reference hereinafter; thence return to Point "A" as referenced herein; therefrom said Point "A", turn an angle to the right of 81 degrees 25' and run North 80 degrees 27' West a distance of 150 feet, more or less, to the point of ending of said thirty (30) foot strip of land.

The applicant also seeks the right and authority to place such guy wire and anchors for a distance not to exceed 15 feet outside of and in a Northeasterly direction from such ways and rights of way at Point "B" and "D" indicated above as may be necessary in the erection, construction, or maintenance of said wire lines and appliances of applicant; also, seeks the right and authority to place such guy wires and anchors for a distance not to exceed 17 feet outside of and in a Southwesterly direction from such way and rights of way at Points "A", "C", and "E" indicated above as may be necessary in the erection, construction or maintenance of said wire lines and appliances of applicant.

The kind of suit brought as above stated is to condemn and acquire easements, interests, ways and rights-of-way in connection with the erection, construction and maintenance of towers, poles, wire lines, guy wires, anchors and other appliances for the transmission, distribution, supply and sale to the public of electric power.
