## AMENDMENT TO ARTICLES OF INCORPORATION

## AMENDMENT TWO

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

## AMENDMENT THREE

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding section of any prior or future Internal Revenue Code or to the Federal, state or local government for exclusive public purpose.

The foregoing amendments were proposed by resolution of the board of directors of the above Corporation and presented to the membership at a regularly scheduled meeting on Oct. 5,1987, 1987. At that time, a quorum was present and all of the foregoing amendments received at least two-thirds of the votes entitled to be cast by members present or represented by proxy as such meeting.


