QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS:

Drake and Annie J. Drake, husband and wife, as joint tenants with the right of survivorship, all its rights, title, claim, interest, equity and estate in and to the following described lands lying in the County of Shelby, State of Alabama, to-wit:

Commence at the SW corner of the NW1/4 of NE1/4 of Section 35, Township 21 South, Range 1 West, being the point of beginning of the parcel of land herein described; thence proceed in a Northerly direction along the West boundary line of said 1/4 1/4 Section a distance of 420.0 feet to a point; thence turn 89 deg. 32' to the right and proceed for a distance of 210 feet to a point; thence turn 89 deg. 32' to the right and proceed for a distance of 420.00 feet to the point of intersetion of the South line of said 1/4 1/4 Section; thence turn 89 deg. 32' to the right and proceed along said South line of said 1/4 1/4 Section for a distance of 210.00 feet to the point of beginning. Said property is lying in the NW1/4 of NE1/4 of Section 35, Township 21 South, Range 1 West, and contains 2.02 ares. Subject to utility easements and road rights of way of record.
