Manufacturers Hanover Financial Services of Alabama, Inc., an Alabama corporation, was merged into Finance One of Alabama, Inc., an Alabama corporation by Articles of Merger filed with the Alabama Secretary of State on September 30, 1985, and a certified copy thereof was filed with the Judge of Probate of Montgomery County, Alabama, on October 2, 1985 in Corp. 0141, Page 0428. Finance One of Alabama, Inc., was thereafter merged into Manufacturers Hanover FS Corporation, a Delaware corporation, by Certificate of Merger filed with the Secretary of State of the State of Delaware effective December 31, 1986 in which the survivor changed its name to Manufacturers Hanover CS Corporation. A certified copy of the said Certificate of Merger was recorded with the Probate Judge in Jefferson County, Alabama on December 31, 1986 at Volume 3080, page 099. Additionally, Articles of Merger evidencing the merger of Finance One of Alabama, Inc. into Manufacturers Hanover FS Corporation were filed with the Alabama Secretary of State on December 31, 1986, and a certified copy thereof was filed with the Judge of Probate of Montgomery County, Alabama, on January 15, 1987, in Corp. 0148, Page 0083.
