ARTICLES OF INCORPORATION
OF
VULCAN PEST CONTROL, INC.

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is VULCAN PEST CONTROL, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: to issue pest control contracts in Alabama and to do all inspections, purchase chemicals, employ personnel, rent space and to do each and every other activity necessary or desirous to issue pest control contracts and inspections, and to do each and every other activity allowed a corporation by the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000), at no-par value per share. There is only one class of stock.

FIFTH: The address of the initial registered office of the corporation is 321 Bearden Road, Pelham, Alabama 35124; the mailing address of the corporation is P. O. Box
