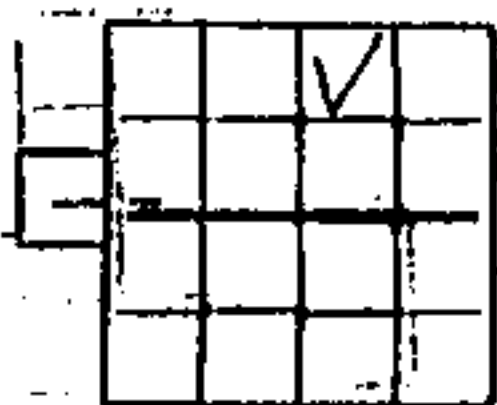

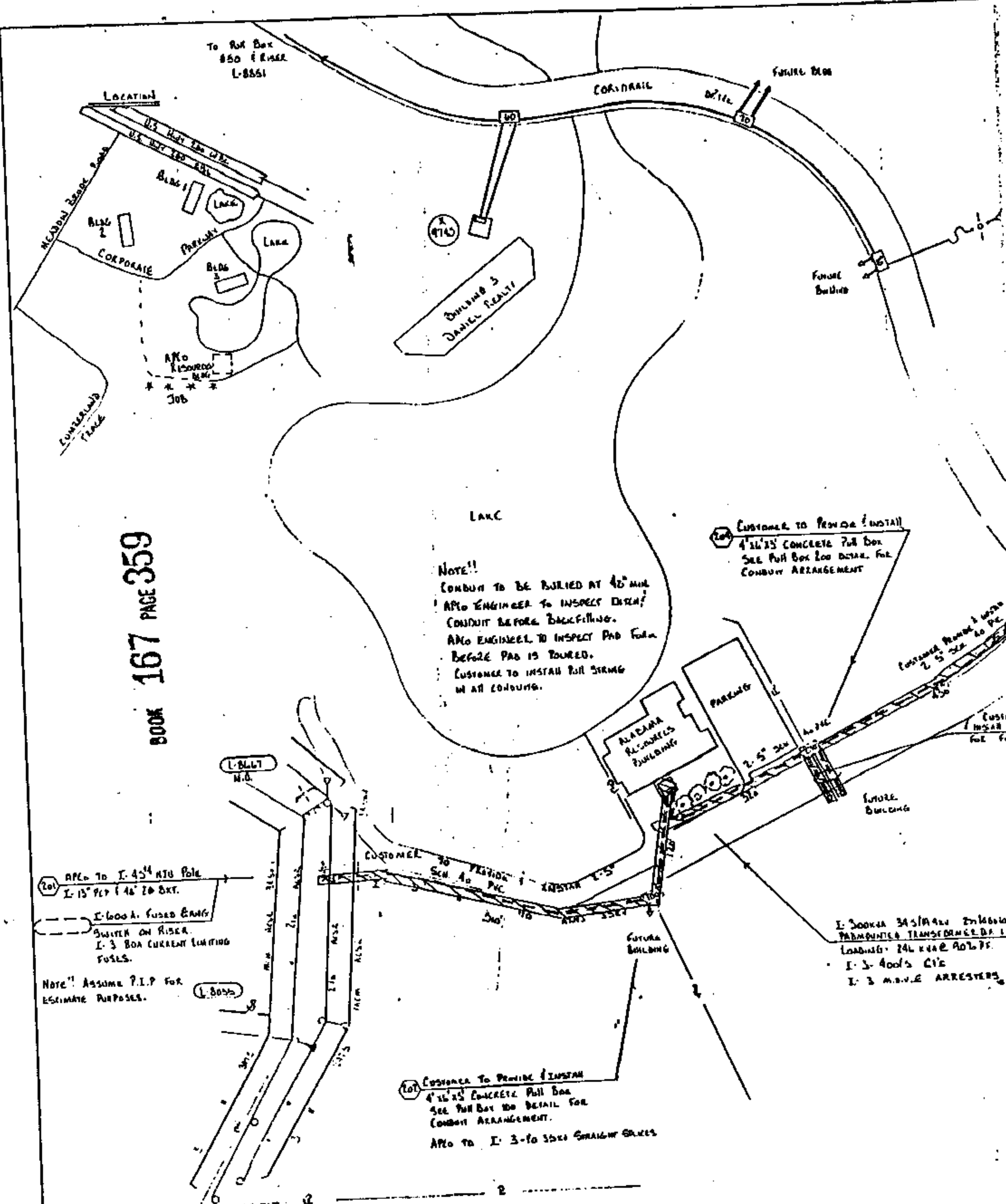
A tract of land in the Northwest Quarter of the Northeast Quarter of Section 6, Township 19 South, Range 1 West described as follows:

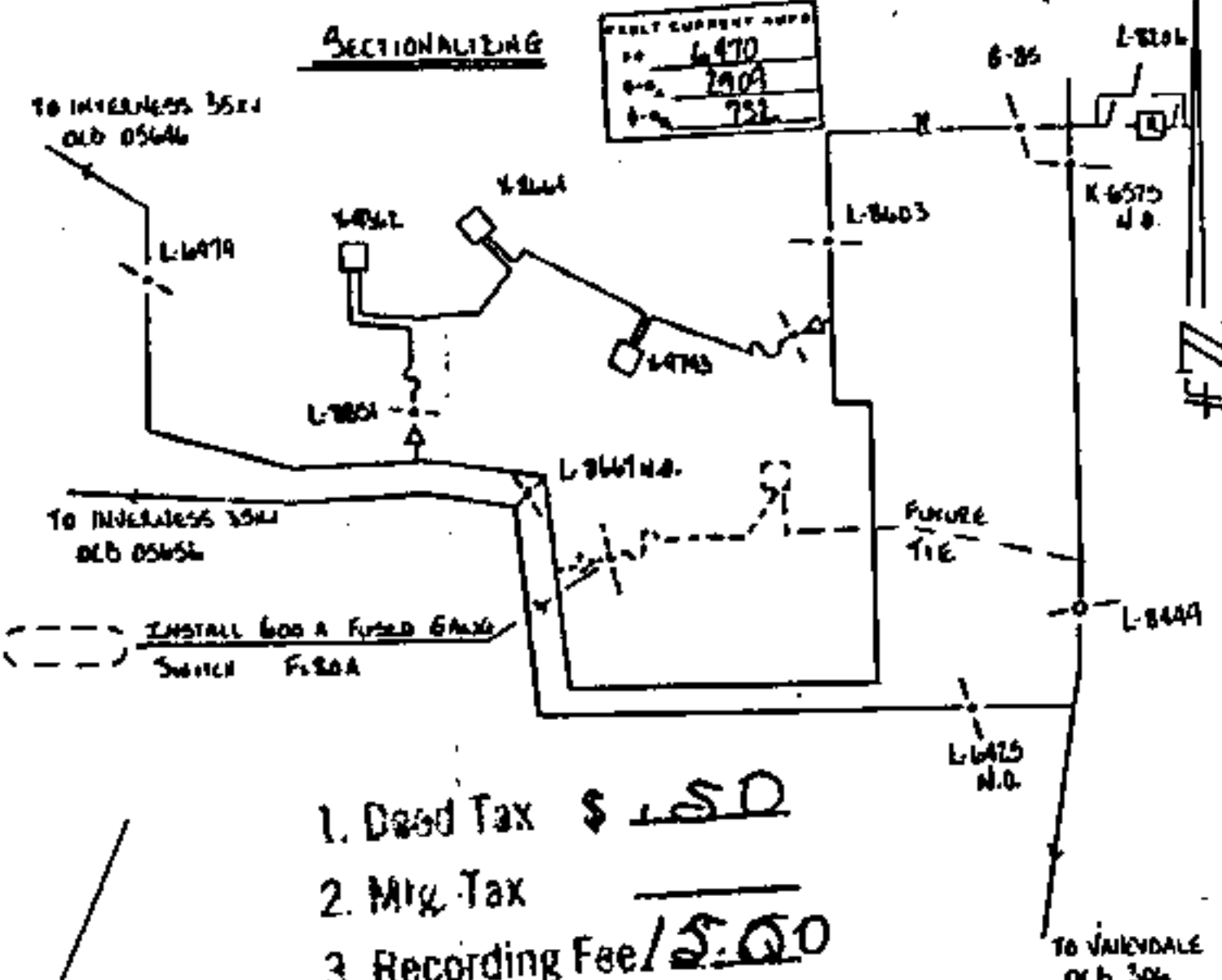

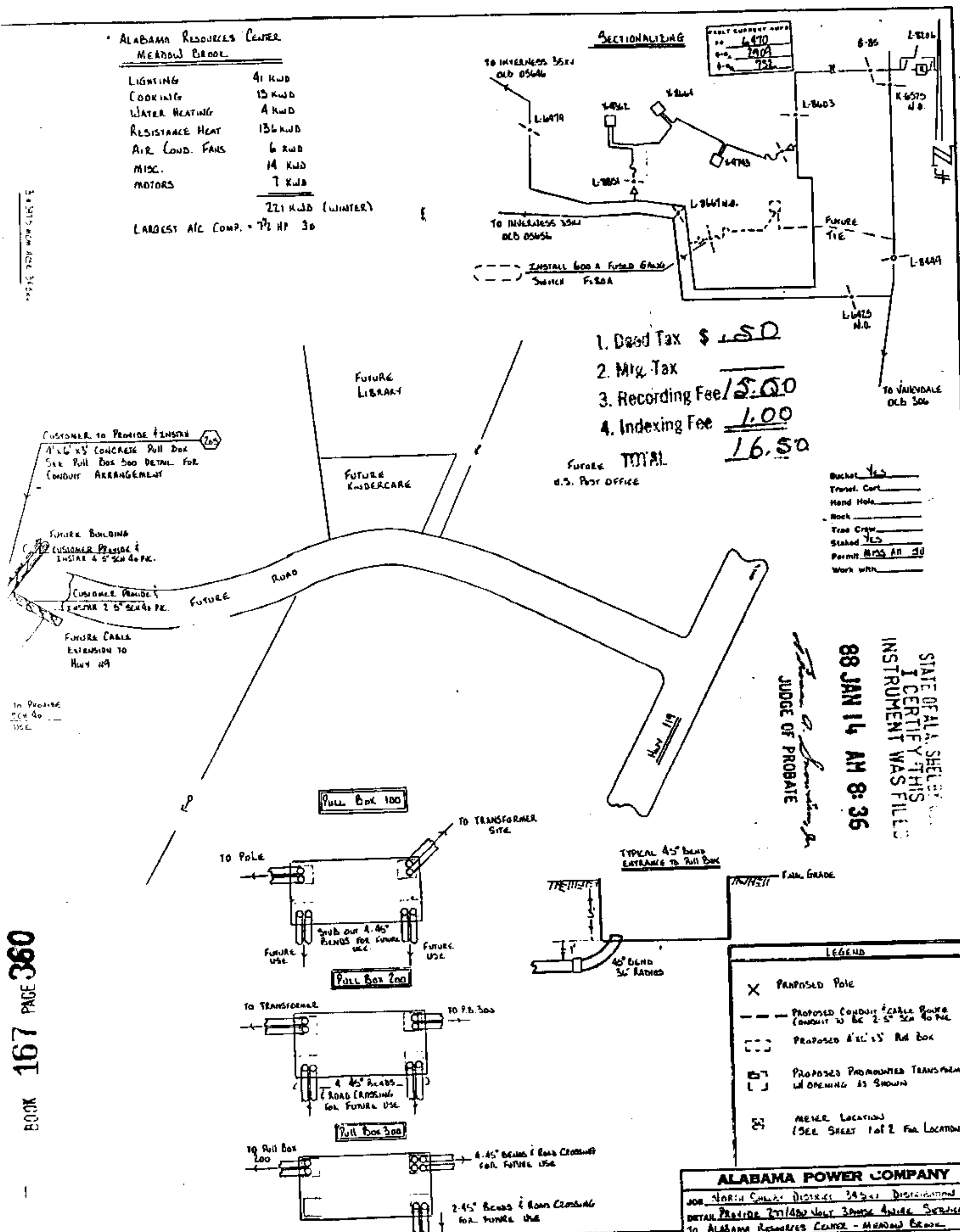
