

# RESURVEY OF LOTS 7, 8, 9, 10 - BLOCK 17 BROKEN BOW, SOUTH


Situated in the SW 1/4 of the SE 1/4, Section 12, Township 19 south, Range 2 west, Shelby County, Alabama.
