I appoint my brother-in-law and my sister, WILLIAM A. JONES and MAE RUTH JONES, of Wetumpka, Alabama, as joint guardians of the property of my said minor children, they to have the complete and exclusive management of their estates. I direct that no bond or other security shall be required of said guardians in any jurisdiction for the faithful performance of their duties as guardians and I further direct that they shall not be required to file any settlement or accounting of their acts as said guardians for said children in any Court. It is my wish and desire that the physical custody of my said children shall be placed with the guardians herein named.

I hereby grant to the guardians herein named the continuing, absolute, discretionary power to deal with any property, real or personal, held in the guardianship as freely as I might in the handling of my own affairs. Such power may be exercised independently and without the prior or subsequent approval of any Court or judicial authority, and no person dealing with the guardians shall be required to inquire into the propriety of any of their actions. Without in any way limiting the generality of the foregoing, I hereby grant to said guardians the following specific powers and authority in addition to and not in substitution of powers conferred by law:

- (A) To retain any security or other property held in the guardianship so long as such retention appears advisable, to exchange any such security or property for other securities or properties and to retain such items received in exchange.
- (B) To sell, exchange, assign, transfer and convey any security or property, real or personal, held in the guardianship at public or private sale, at such time and price and upon such terms and conditions as they may determine.
- (C) To invest and reinvest in such stocks, bonds, certificates of deposits, and other securities and properties as they may deem advisable.
- (D) To sell or exercise any "rights" issued on any securities held in the guardianship.
- (E) To vote in person or by proxy any stock or securities held, and to grant such proxies and powers of attorney to such person or persons as they may deem proper.
- (F) To employ accountants, attorneys and such agents as they may deem advisable; to pay reasonable compensation for their services and to charge same to income and principal as they may deem proper.
- (G) To expend such sums as they, in their sole discretion, deem necessary or desirable for the care, maintenance, up-keep, education, and support of the said minor children. It is my wish and desire that the said guardians shall have complete and total discretion in expending whatever funds they see fit for the benefit of my said children.

ARTICLE V
