or ordinances; and if the plumbing work or gas work done or supervised by said Principal complies with the provisions of all laws and ordinances relating to plumbing and/or gas work and applicable thereto, and if all damages arising from said plumbing or gas work, said plumbing work or gas work failing to comply with the requirements of any State laws applicable thereto, or with the ordinances of any municipal corporation applicable thereto, are paid by said Principal to the person, firm or corporation sustaining said damages; and shall perform in a workmanlike manner all work undertaken by said Principal, it's servants and agents, in doing said work or from any unfaithful or inadequate work, and shall adequately safeguard all ditches and excavations which may be opened by said Principal in the State of Alabama; and shall restore, or cause to be restored, in a workmanlike manner, to their former condition, all such portions of said streets excavated by said Principal, and pay the expenses thereof; and shall maintain said restored portions in a safe condition for the period of one year from the date of such excavation; and shall defend all suits brought against the State based, in whole or in part, upon any act or default for which said Principal is responsible, and pay the costs and expenses thereof, and shall pay all such damages as any person, firm or corporation may sustain by reason of violation of said laws; ordinances or regulation by said Principal, it's servants and or agents, in the prosecution of said business or businesses, then this bond to be void, otherwise to remain in full force and effect.

We, and each of us, hereby waive all exemptions we may have to any property under the Constitution and laws of the State of Alabama as to the collection of the pentalty of this bond.
