Frye and Wife, Nina A. Frye, one-half (1/2) thereof to Raymond P. Hagerman and Wife, Christine V. Hagerman, and one-half (1/2) thereof to Griffin P. Martin and Wife, Betty J. Martin, which includes all principal and interest now due or to become due until said note is paid in full, together with all of the undersigned's interest in and to that certain mortgage securing said note dated August 18, 1982, and filed for record in Real Volume 423, Pages 154 and 155 in the Office of the Judge of Probate of Shelby County, Alabama, the intent of the undersigned being to assign said note and mortgage equally to Raymond P. 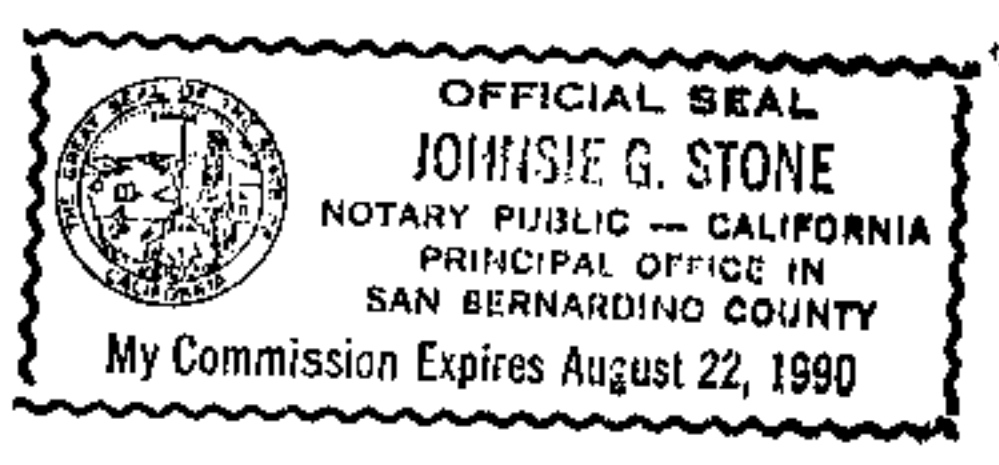
