That in consideration of ONE HUNDRED THIRTY TWO THOUSAND AND NO/100 DOLLARS (\$132,000.00) to the undersigned grantor, VISION HOMES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the Grantees herein, the receipt of which is hereby acknowledge, the said GRANTOR does by these presents, grant, bargain, sell and convey unto JOHN GILBERT DUNNING, JR. AND R. MICHELLE DUNNING (herein referred to as Grantees) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

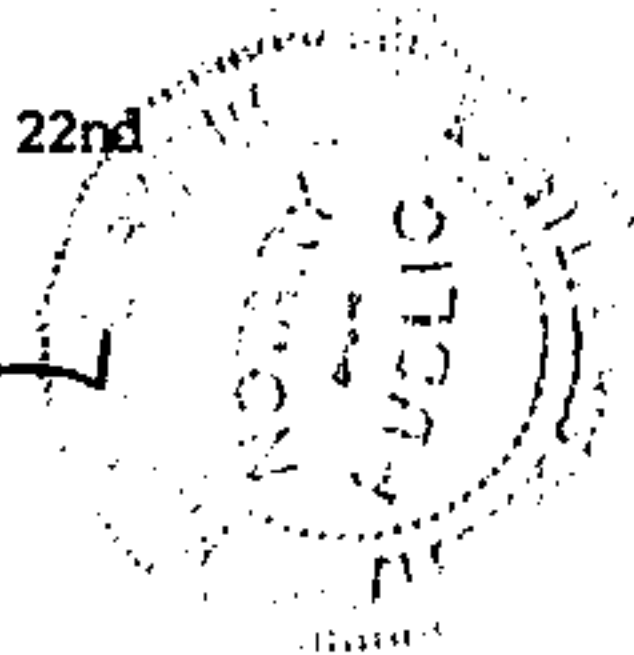
