POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, PERNIE GIBSON HOWELL, a resident of Calera, Shelby County, Alabama, being desirous of arranging for the transaction of my business through an attorney in fact, have appointed, named and constituted, and by these presents do name, constitute and appoint JAMES M. SUTHERLAND, Route 3, Hunter Road, Douglasville, Georgia, as my true and lawful attorney in fact, and do authorize said attorney in fact, to act for me, and in my name, place and stead. Should James M. Sutherland die, become incapacitated, or for any reason be unable to act, then in that event, I appoint GRIZELDA MAYHALL, a resident of Haleyville, Winston County, Alabama, as successor attorney in fact. In the event she for any reason cannot act, then I appoint her son, DONALD MAYHALL, to act in her stead with all of the powers herein given to act in my stead.

(a) To sell, mortgage, encumber, convey, rent, lease, pledge, or otherwise dispose of, by deed with or without warranty, bill of sale, contract or otherwise, any property, real or personal, which I may own or in which I may have an interest, or which I may hereafter acquire, located in the State of Alabama, for cash or upon such terms as said attorney in fact may deem advisable, and to execute appropriate deeds, conveyances or other instruments including contracts for that purpose. This specifically includes my homeplace located in the township of Calera, Shelby County, Alabama.

(b) To sign, endorse, receive, deposit or issue checks, bonds, notes, stocks or other obligations or instruments, and to borrow money and secure the same in any manner.

(c) To collect, sue for, settle, adjust or compromise any claim for money arising by contract or tort, to execute releases, cancellations or satisfactions, and

(d) To do any other thing or perform any other act, not limited to the foregoing, which I might do in person, it being intended that this shall be a general power of attorney to execute and perform as I might, or could do if I were personally present and hereby ratifying and confirming all that my said attorney shall lawfully do by virtue hereof.

This Power of Attorney may not be revoked except by an instrument in writing, duly witnessed. It Supercedes all prior Powers granted.
