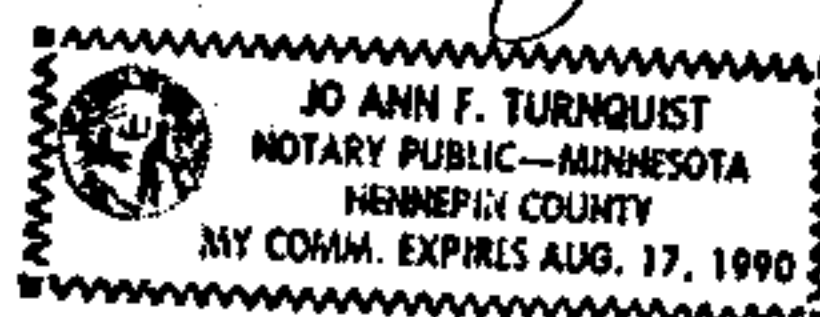

# SCHEDULE "A"

Commence at the Southeast corner of the Northwest Quarter of the Northwest Quarter of Section 13, Township 19 South, Range 2 West and run north along the east line of said Quarter-Quarter Section a distance of 295.79 feet to the point of Beginning; thence continue along the east line of said Quarter-Quarter Section a distance of 373.0 feet; thence turn an angle left 43 degrees 53 minutes 30 seconds and run northwesterly a distance of 179.95 feet to the point of a curve to the left having a radius of 90.0 feet and a central angle of 93 degrees 02 minutes thence run along the arc of said curve a distance of 146.14 feet to the point of Tangent of said curve; thence run southwesterly a distance of 166.08 feet; thence turn an angle left 29 degrees 38 minutes 30 seconds and run a distance of 190.35 feet; thence turn an angle right 21 degrees 23 minutes and run a distance of 143.37 feet; thence turn an angle left 110 degrees 18 minutes and run a distance of 87.50 feet; thence turn an angle left 6 degrees 47 minutes 30 seconds and run a distance of 413.92 feet to the point of beginning.

Subject to a 16 foot wide ingress and egress easement being 8 feet a on each side and parallel to the following described centerline; Commence at the Southeast Corner of the Northwest Quarter of the Northwest Quarter of Section 13, Township 19 South, Range 2 West and run north along the east line of said Quarter-Quarter Section a distance of 295.79 feet; thence 82 degrees 16 minutes 30 seconds left and run northwesterly 405.36 feet to the Point of Beginning of the centerline of said easement; thence 81 degrees 06 minutes 22 seconds right and run northerly a distance of 139.74 feet; thence 14 degrees 36 minutes 08 seconds right and run Northeasterly a distance of 203.54 feet to a point on the southerly right-of-way line of Cahaba Valley Cove Road; said point being the end of herein described easement centerline. Being situated in Shelby County, Alabama.
