DECLARATION OF PROTECTIVE COVENANT

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, the undersigned, KENNETH VANSISE, ANN UNDERWOOD VANSISE, ELWOOD M. VANSISE and DAVID L. HATCHER (the "Declarants"), are the owners of all of the following described property:

Begin at the Southeast corner of the SW 1/4 of the SW 1/4 of Section 27, Township 17 South, Range 1 East, Shelby County, Alabama; thence run along the South line of said Section North 88 degrees 59' 03" West a distance of 359.07 feet; thence run North 0 degrees 04' 27" East a distance of 2658.87 feet; thence run South 88 degrees 48' 28" a distance of 361.69 feet; thence run South 0 degrees 06' 52" West a distance of 2657.74 feet to the point of beginning. Containing 22 acres, more or less.

WHEREAS, the undersigned desire to subject said Property to the conditions, limitations and restrictions hereinafter set forth.

NOW, THEREFORE, the undersigned do hereby expressly adopt the following protective covenants, conditions and limitations for said subdivision, to-wit:

That said Property shall be and the same are hereby subject to the following conditions, limitations and restrictions.

Beginning on September 1, 1992 and thereafter, no mobile homes will be permitted to be placed upon the property.
