If Buyer gets over the blue painted land line and cuts a tree or trees on some one else's property it will be the buyers responsibility to pay for the	hem.

Buyer will remove all tree tops which fall into woods road as felled. Fix all pasture fences if damaged when it happens.

Payment in lump sum by CASHIERS CHECK.

It is clearly understood that the Seller shall not be liable to Buyer for any loss of timber substained by Buyer caused by fire, storm or other causes. Nor his machinery on my property.

The paved road you leave to go into woods where the timber is to be cut. It is clearly understood you fix the place where no cars or anything else can go through when the job is finished. Make no new roads going to where my timber is. Go the old road IN and OUT.

Three(3) months to cut timber. jor in case of Bad weather am additional 3 months.

' In the event the Buyer fails or refuses to preform the obligations of the Sellers herein and money paid to the Sellers from the Buyers shall be and become the property of the Sellers in liquidation of any damage suffered by the Sellers, by the reason of the failure of the Buyer.

For and in consideration of the rights granted to the Buyer under this contract, Buyer agrees to idemnify protect, save and hold harmless Sellers from and against any and all loss, damage or expense which Sellers may suffer or sustain or be liable for and against any and all claims, demands and suits as a result of injury or death of person and/or damage injury to property in whatever manner the same may be caused or occassioned, which arises out or in anyway connected with the performance of any work under or related to this contract, including but not limited to payments made under and Workmens Compensation Law or under any plan for employee's disability and death benifits and any claims asserted by Buyersemployee's, laborers, or furnishing materials or supplies to the said work covered by this contract.

It is agreed that while engaged in cutting and removing said timber the Buyer and the Agents and Employee's of the Buyer and their agents and employee's shall be especially bound to exercise reasonable diligence to prevent forrest fires upon said land within the time limit covered by this instrument which timber is removed. That is is futher agreed that garbage and litter be not left on the ground.
