TO THE HONORABLE JUDGE OF PROBATE OF JEFFERSON COUNTY, ALABAMA:

William M. Humphries, President, and Larry F. Silvers, Secretary, of W. M. Humphries Development Company, Inc., do hereby certify the following:

1. W. M. Humphries Development Company, Inc. was organized under the laws of the State of Alabama on December 21, 1961, with its principal place of business in Birmingham, Alabama. A Certificate of Incorporation under the name "W. M. Humphries Development Company, Inc." was filed in the Office of the Judge of Probate of Jefferson County, Alabama, and recorded in Incorporation Volume 138, Page 866.

2. The following Amendment to the Certificate of Incorporation, which changes the name of the corporation, has been adopted by the unanimous consent of all the stockholders and directors of said corporation, in accordance with the provisions of Title 10, Section 21(20), Code of Alabama, and said consent of the stockholders and directors has been signified by the signature of each, attested by two witnesses, to a copy of the following Amendment:

"The Certificate of Incorporation is hereby amended by changing the name of the corporation from W. M. Humphries Development Company, Inc. to W. M. Humphries Enterprises, Inc. The name W. M. Humphries Development Company, Inc. is deleted from the Certificate of Incorporation in every place that it appears therein and the name W. M. Humphries Enterprises, Inc. is substituted in lieu thereof. Article I of the Certificate of Incorporation is hereby specifically amended by striking said Article in its entirety and substituting the following Article I in lieu thereof:

'ARTICLE I

'Name

'The name of the corporation shall be: W. M. Humphries Enterprises, Inc.'"
