ASSIGNMENT OF INSTALLMENT SALES CONTRACTS

THIS ASSIGNMENT, made and entered into as of this 277A day of April 1989, by and between SOUTHERN CAPITAL FINANCE NUMBER ONE, INC. and SOUTHERN CAPITAL FINANCE NUMBER TWO, INC. (collectively referred to as "Assignors") and CENTURY FEDERAL SAVINGS BANK (the "Assignee").

WHEREAS, on January 28, 1987, SOUTHERN CAPITAL FINANCE NUMBER ONE, INC. issued a series of bonds to Assignee and the Peoples Bank of Elk Valley. On April 9, 1987, SOUTHERN CAPITAL FINANCE NUMBER TWO, INC. issued a series of bonds to Assignee. Both of the referenced bond issues were collateralized by mobile home installment sales contracts. Pursuant to the Indenture of Trust concerning each bond issue, the Assignors transferred all of their right, title and interest to certain mobile home installment sales contracts to the bond trustee, the Valley Fidelity Bank and Trust Company, Knoxville, Tennessee ("Valley Bank").

WHEREAS, an agreement was executed on September 27, 1988, by and between all parties mentioned herein, and others, whereby the respective bond issues referred to above were rescinded and terminated in all respects;

WHEREAS, as a result thereof, the Valley Bank, by Assignment dated December 29, 1988, assigned all of its interest in the installment sales contracts, as well as other

collateral, to the bond holders, Century Federal Savings Bank and the Peoples Bank of Elk Valley. A copy of the Assignment of Installment Sales Contracts is attached hereto and labeled Exhibit 1;

WHEREAS, it has come to the attention of Assignee that certain of the documents reflecting ownership interests in the mobile homes and/or the installment sales contracts reflect the secured party or the owner to be Southern Capital Finance Number One, Inc. or Southern Capital Finance Number Two, Inc;


WHEREAS, it is the intention of the Assignors to assign all right, title and interest in all property collateralizing bond issues referenced above to the bond holders, Century Federal Savings Bank and/or the Peoples Bank of Elk Valley.



ASSIGNMENT OF INSTALLMENT SALE CONTRACTS

This ASSIGNMENT, made and entered into as of this 29th day of December, 1988, by and between VALLEY FIDELITY BANK AND TRUST COMPANY, Knoxville, Tennessee (herein "Assignor"), CENTURY FEDERAL SAVINGS & LOAN ASSOCIATION, Trenton, Tennessee ("Century"), and PEOPLES BANK OF ELK VALLEY, Fayetteville, Tennessee ("Peoples'Bank") (herein individually "Assignee" and jointly "Assignees").

## WITNESSETH:

WHEREAS, on January 28, 1987 Southern Capital Finance Number One, Inc. issued a series of bonds to Century and Peoples Bank. Such bonds are referred to in the bond documentation as Collateralized Mortgage Obligations and Series 1987-A Bonds. These bonds are in the face amount of \$18,075,000.00 and one hundred (100%) percent of same were issued to Century and Peoples Bank. These bonds were secured by certain installment sale contracts. Assignor, in its fiduciary capacity, served as Trustee under the Indenture of Trust collateralizing this bond issue; and

WHEREAS, on April 9, 1987 Southern Capital Finance Number Two, Inc. issued bonds in the aggregate amount of \$1,000,000.00. Such bonds are referred to in the bond documentation as Collateralized Mortgage Obligations and Series 1987-A Bonds. One hundred (100%) percent of these bonds were issued

to Century. Assignor also served as Trustee under the Indenture of Trust collateralizing this bond issue; and

WHEREAS, Assignor, as Trustee under the respective Indentures of Trust referred to above, is the lawful holder of a series of installment sale contracts financing the acquisition of manufactured homes and is the lawful holder of the certificate of title to such financed manufactured homes and/or related deeds of trust, mortgages, financing statements, policies of insurance naming Assignor as additional insured, and other instruments evidencing related secured interests, which together create a first priority lien in favor of Assignor in the property financed by the installment sale contracts (herein "Installment Sale Contracts"); and

WHEREAS, an Agreement was executed on September 27, 1988, by and between all parties mentioned herein, and others, whereby the respective bond issues referred to above were rescinded and terminated in all respects; and

WHEREAS, as a result thereof, Assignor desires to assign and transfer to Assignees all of Assignor's right, title and interest in and to the Installment Sale Contracts.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The Assignor does hereby assign, transfer and set over unto the Assignees, with full power to sell, convey, and or

encumber and without the necessity of the purchaser looking to the application of the proceeds, all of Assignor's right, title and interest in and to the Installment Sale Contracts, respectively to each Assignee, as listed on Schedule A, which Installment Sale Contracts include, but are not limited to, the original of such financing contracts, the original of the obligor's note, any and all financing statements related to each contract, any security interest in the property financed by the contracts whether by way of certificate of title, mortgage, deed of trust, financing statement, or any other instrument or document representing a security interest by the holder of the contract in the property financed with such contract, the collateral relating thereto, all repossessed mobile homes from such assigned contracts, together with all policies of insurance related thereto and any other proceeds from the collateral or the Collateral Preservation Funds of the bond issues.

2. Additionally, Assignor does hereby assign, transfer and convey to Assignees all rights it has to any property of any nature collateralizing the Collateralized Mortgage Obligation referred to above, including those Installment Sale Contracts and/or units securing same as listed in Schedule B. The parties acknowledge that the Installment Sale Contracts and/or units listed in Schedule B were not in the possession of the Assignor as of the date of this agreement.

3. Assignor represents to the Assignees that Assignor is the lawful and rightful holder of the Installment Sale

Contracts pursuant to the terms of the Indentures of Trust referred to above, and has full right and power as such Trustee thereunder to convey Assignor's full right, title and interest in and to such Installment Sale Contracts.

4. Assignor, expressly disclaims any representations or warranties and the Assignees, Century and Peoples Bank, agree to assume and perform all duties and obligations that Assignor has and shall indemnify and save Assignor harmless from any and all claims, demands, actions, causes of action, suits, proceedings, damages, liabilities and costs and expenses of every nature whatsoever relating to this Assignment.

5. Assignor further agrees to execute and deliver to Assignees any and all documentation and instruments necessary to transfer Assignor's rights in the Installment Sale Contracts, including certificates of title, UCC-1's, deeds of trust, mortgages, insurance policies (including casualty, loss payee and credit insurance on the Installment Sale Contracts or the property which secures such contract) and other documentation which might be required to protect Assignees' rights, title and interest in the Installment Sale Contracts. Assignees agree, as they deem necessary and at their own expense, to notify each obligor under any Installment Sale Contracts as to the transfer of lienholder and instructions as to when and where such obligors should send any and all future payments and correspondence on and relating to the Installment Sale Contracts.

6. All of the covenants, terms, and conditions set forth herein shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, successors and assigns.

7. This Assignment shall be governed by and interpreted under the laws of the State of Tennessee.
