non-exclusive right to use from time to time roads for roadway purposes for  
its vehicles and equipment located or to be constructed by grantor upon,  
over and along the following described land situated in Shelby  
County, Alabama to wit:

Such roads are more particularly described as follows:

See road locations colored in red on map attached  
as Exhibit "A" and incorporated herein by reference

Together with the right to cross grantor's property with such vehicles  
and equipment at other locations in the event said existing roads be closed  
in the future, provided, however, that grantor may designate such other  
locations to the extent the same represent routes comparable to those set  
forth in Exhibit "A". In addition, grantee is granted all the rights and  
privileges necessary or convenient for the full enjoyment or use of the  
rights of way herein granted, including the right to grade, drain, fill,  
bridge, or improve such rights of way. Upon each use of such access road,  
grantee agrees that it will leave such road in the same or better condition  
as such road was in immediately prior to such use by grantee.

assigns, forever.

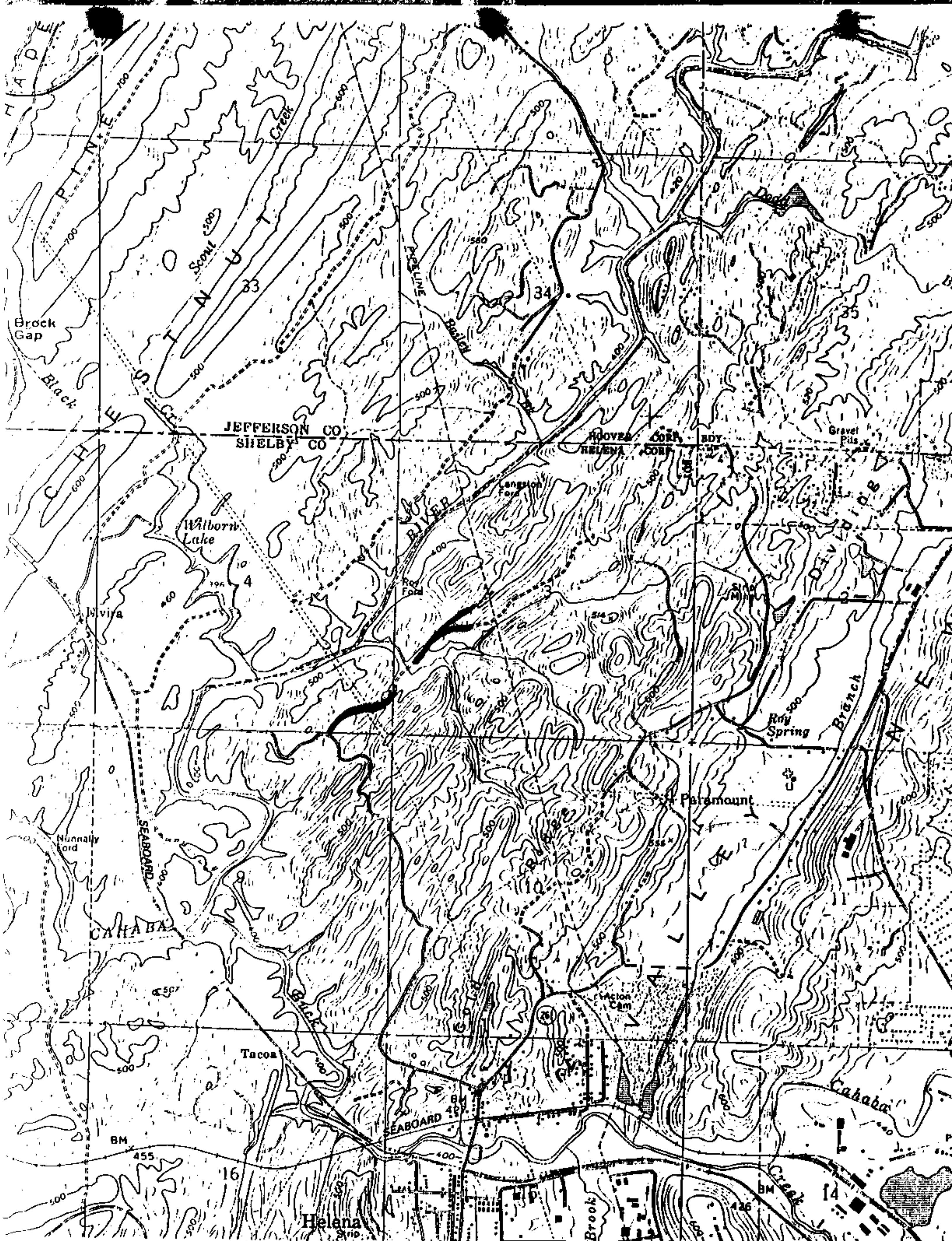
