## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF SOUTHERN HILLS CHRISTIAN CHURCH

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

3. The Amendment was adopted at a meeting of the members of the corporation held January 20, 1990, at which meeting a quorum of members was present, and such amendment received the vote of at least two-thirds of the votes entitled to be cast by members present or represented by proxy at such meeting.


