AMENDMENT TO ADJUSTABLE-RATE LINE OF CREDIT MORTGAGE

This Amendment (the "Amendment") is made and entered into on March 26 , 19 90 , by and between Aubrey W. King. III and wife, Linda P. King (hereinafter called the "Mortgagor", whether one or more) and AmSouth Bank N.A., a national banking association (hereinafter called the "Mortgagee").

- B.
