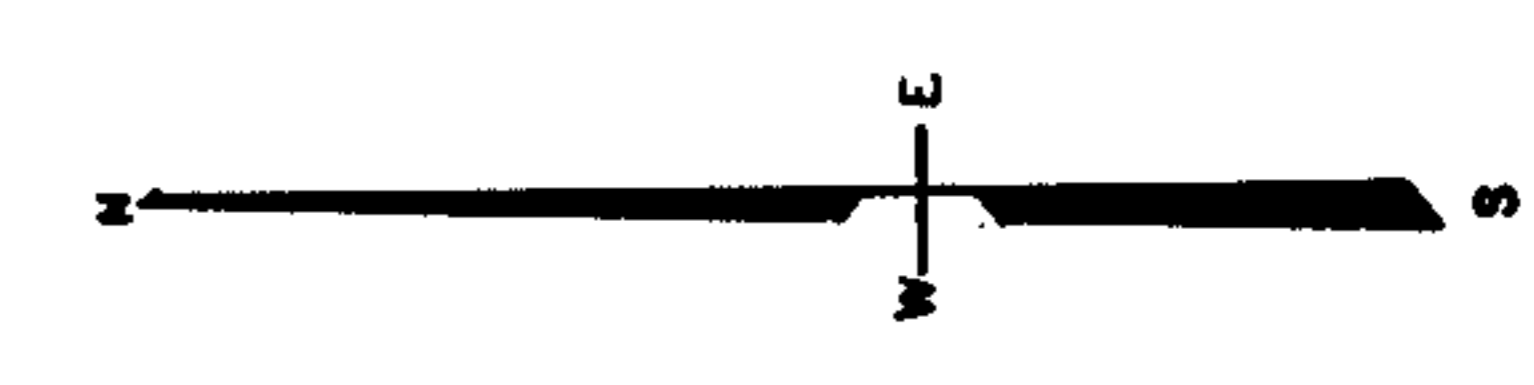
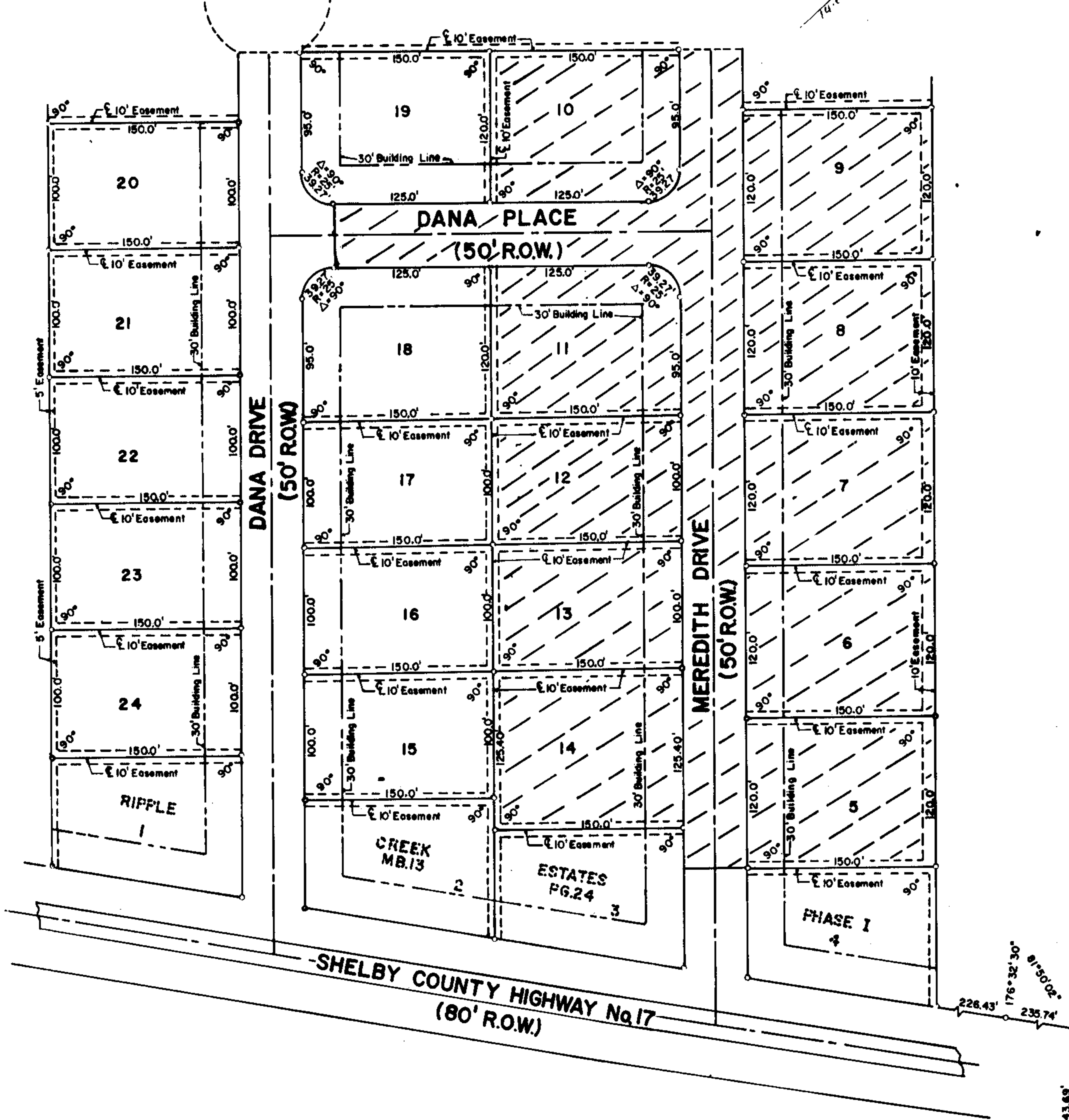

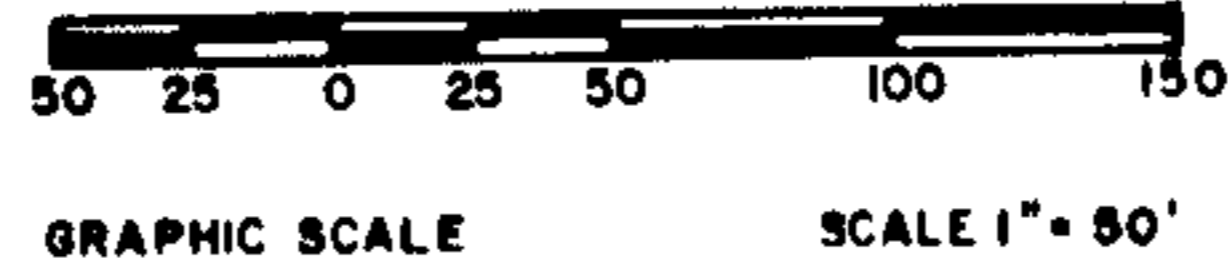

 7. Lot 14 contains 18,000 square feet.
 8. Lots 10, 11, 18 and 19 contain 17,000 square feet each.
