AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS C. T. Daniel, a single man executed that certain mortgage to Gerald W. Espey and wife, Linda D. Espey, dated August 12, 1988, recorded on August 12, 1988, in Real Record 200, Page 959, which said mortgage was assigned to Central State Bank by assignment dated August 12, 1988, recorded in Real Record 200, Page 961, and

WHEREAS, C. T. Daniel is now in default in the payment of said indebtedness; and

WHEREAS, Gerald W. Espey and wife, Linda D. Espey have continued to make the payments to Central State Bank under the terms of the Assignment and

WHEREAS, Gerald W. Espey and wife, Linda D. Espey desire to undertake foreclosure proceedings against C. T. Daniel, and

WHEREAS, Central State Bank is willing to allow Gerald W. Espey and wife, Linda D. Espey to foreclose said mortgage, the parties hereto agree as follows:

1. Central State Bank will re-assign said mortgage to Gerald W. Espey and wife, Linda D. Espey for purposes of foreclosing said mortgage. It is expressly understood that the indebtedness secured by the original assignment to Central State Bank remains unpaid, and that this assignment is given only to facilitate the foreclosure of the mortgage.

2. Upon proper foreclosure of said mortgage, Gerald W. Espey and wife, Linda D. Espey will execute a new mortgage to Central State Bank in the amount of their present indebtedness or in the event that a third party purchases the property at foreclosure, the debt will be paid in full.
