ARTICLES OF INCORPORATION

FIRST: The name of the corporation is Vista Homes, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To own and operate a business engaged in the construction of residential and commercial structures, remodeling, real estate acquisitions and sales and property management; to engage in any lawful business or activities related to the stated purposes; and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.
