

ARTICLES OF INCORPORATION OF SHELBY MARKETING, INC.

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA

The undersigned J. A. Tibbals, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporations:

- 1. The name of the corporation shall be Shelby Marketing, Inc. and the corporation shall be authorized to operate under said name or use any other trade name not now being used by another person, firm or corporation.
- 2. The purposes of the corporation, and for which same was formed are as follows:

For the sale of advertising to Individuals, Retail and Wholesale Merchants (classified & display) in weekly, monthly and/or bi-monthly tabloids and/or other printed publications and the publication and distribution of such advertising media.

For the sale of business opportunities, regardless of whether it be considered a distributorship, licensee, franchise, working partner agreement or of other legal description to be decided by separate legal papers pertaining to each individual.

To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.


'7. The period for the duration of the corporation shall be perpetual.
