This power of attorney shall not terminate on disability of the principal. This power of attorney shall commence and be in full force on August 30, 1990 and shall remain in full force and effect until a revocation of such power of attorney has been duly recorded in the Office of the County Clerk in which the above described property is located and a copy of such revocation is mailed by certified mail, return receipt requested to NANCY P. PATTERSON, P. O. Box 944, Addison, Dallas County, Texas. Notwithstanding the foregoing, this power of attorney shall terminate on its own terms December 31, 1990, unless termination is accomplished by the method previously mentioned.

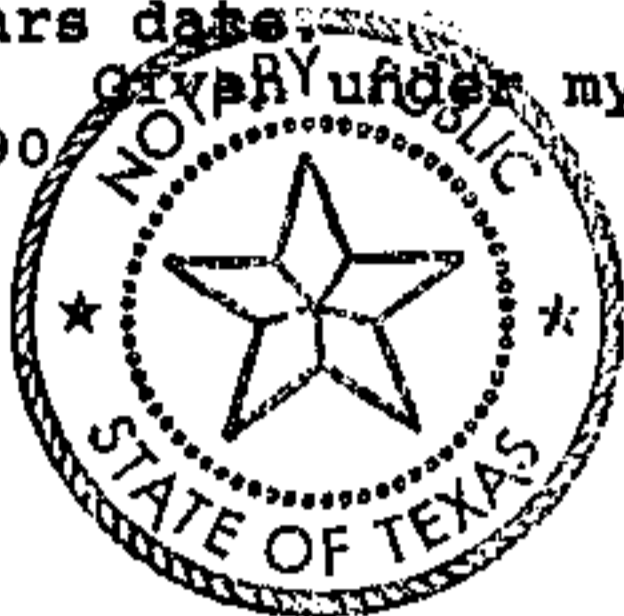

EXHIBIT "A"

Lot 26, and a part of Lot 25, according to the Survey of Meadowridge as recorded in Map Book 11, on page 40 A & B, in the Office of the Judge of Probate of Shelby County, Alabama, being more particularly described as follows: Begin at the Northwest corner of said Lot 25, said point being the common corner between Lot 25 and 26; thence run in a southeasterly direction along the North line of said Lot 25 and also along the South line of said Lot 26, for a distance of 223.81 feet to the Northeast corner of said Lot 25; thence turn an angle to the right of 98 degrees, 18 minutes, 43 seconds and run in a southwesterly direction along the southeast line of said Lot 25 and also along the Northwest line of Lot 10, Windsor Estates, recorded in Map Book 9, page 132 A & B in the Office of the Judge of Probate, Shelby County, Alabama, for a distance of 14.80 feet to the Southwest corner of said Lot 10; thence turn an angle to the right of 84 degrees, 45 minutes, 05 seconds and run in a Northwesterly direction for a distance of 222.07 feet to a point on a curve which is concave to the Northwest having a central angle of 3 degrees, 01 minutes, 48 seconds and a radius of 55.00 feet, said point being on the Southeast right of way of Westminster Circle; thence run in a northerly direction along the arc of said curve and also along said Westminster Circle for a distance of 2.91 feet to the point of beginning.
