ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Alabama Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Delta Chi Alumni/Active Fraternal Association and Housing Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are as follows: (i) to conduct and promote activities and functions for the pleasure and recreation of all persons who have been or are hereafter initiated by the Montevallo Chapter of the Delta Chi Fraternity as members of said fraternity or who otherwise become members of this corporation and (ii) to rent, lease, purchase, construct, own, and operate a fraternity facility for use by the members of this corporation and the members of the Montevallo Chapter of Delta Chi Fraternity. Provided, however, that the purposes and powers of the corporation shall be limited to the extent necessary in order for this corporation to be qualified as a corporation described in and defined under Section 501 (c) (7) of the Internal Revenue Code, and any and all permissible regulations promulgated thereunder.

FOURTH: The address of the initial registered office of the corporation is 2439 Indian Lake Drive, and the name of its initial registered agent at such address is Steven G. Legg.

FIFTH: The members of this corporation shall include (i) all persons who have been or hereafter may be initiated by the Montevallo Chapter of Delta Chi Fraternity as members of such fraternity and (ii) all other persons who are admitted as members as provided in the By-Laws. The determination of those of the members who are in good standing and the voting rights of the members shall be made in the manner provided in the By-Laws as the same may be amended from time to time.
