WHEREAS, on August 10, 1989, RTC as Receiver for Old Unifirst entered into a Purchase and Assumption Agreement with New Unifirst whereby all right, title and interest in and to the instrument described below was conveyed to New Unifirst;

WHEREAS, on August 10, 1989, pursuant to Order No. 89-16 of OTS, RTC was appointed as Conservator of New Unifirst;

WHEREAS, RTC as Receiver for Old Unifirst desires to memorialize its transfer of the instrument described below to New Unifirst and RTC as Conservator for New Unifirst desires to transfer its interest to Magnolia Federal Bank for Savings.
