In addition to the heirs at law named above, the codicil named as devisees the spouse and children of his deceased son, Cecil Busby, who died on July 21, 1980. Their names, ages, and condition in life at the death of W. A. Busby were as follows: Maurine Virginia Busby, age 62 years, of sound mind; Mary Virginia East, age 41 years, of sound mind; Richard Dale Busby, age 34 years, of sound mind; Michael Wilburn Busby, age 32 years, of sound mind; John

Tipton Busby, age 27 years, of sound mind; and Angela Paige Milstead, age 24 years, of sound mind. With the exception of Eloise Busby, all of the above heirs and devisees are still alive and of sound mind.

I, W. A. BUSBY, of Calera, Shelby County, Alabama, being of sound mind and disposing memory, do hereby publish and declare this my last Will and Testament, revoking all former and otherwills and testamentary dispositions by me at any time heretofore made:

FIRST: I direct that all of my just debts, including the expenses of my last illness and funeral, shall first be paid out of my estate by my Executrix hereinafter named, as soon as the prudent and orderly administration of my estate will permit.

SECOND: I give and bequeath unto my beloved wife, ELLA BUSBY, all of my personal property, wheresoever situate, of which I may die seized or possessed, or to which I may be entitled at the time of my decease.

THIRD: All the rest and residue of my property, real, or mixed, wheresoever situate, of which I may die seized or possessed, or to which I may be entitled at the time of my decease, I give, devise and bequeath to my beloved wife, ELLA BUSBY, for and during her lifetime, together with the power to convey, lease, sell, mortgage, or otherwise encumber, or dispose of any or all of said property, should she in her sole discretion deem it necessary or advisable for her comfort, upkeep and desires.

FOURTH: I further direct that if, upon the death of my said wife, any of such property herein devised or bequeathed shall remain undisposed of, then and in that event, I direct that the same shall be divided equally among my beloved sons, LOUIE BUSBY, CECIL BUSBY, JAMES BUSBY, and JERRY BUSBY, in equal parts, share and share alike. If at such time any of my said children are deceased, leaving lineal heir or heirs, then the said heir or heirs shall take the share of their father, in equal parts, share and share alike, per stirpes.

FIFTH: I hereby nominate and appoint my said wife, ELLA BUSBY, to be the executrix of this Will. In the event she be unable, unwilling, or disqualified to act as such executrix, I nominate and appoint my son, LOUIE BUSBY to be such executor, and I direct that neither of the aforementioned be required to make bond, or file an inventory, or to report their acts and proceedings as such executor to any court.

FIRST CODICIL TO  
LAST WILL AND TESTAMENT  
OF  
W. A. BUSBY

I, W. A. Busby, a resident of Shelby County, Alabama, being of sound mind and disposing memory, do hereby make, publish and declare, this instrument as and for a codicil to my LAST WILL AND TESTAMENT dated August 11, 1966.

FIRST: I hereby amend my LAST WILL and TESTAMENT dated August 11, 1966 by providing that the Fourth paragraph of my said LAST WILL AND TESTAMENT be deleted in its entirety and the following new Fourth paragraph substituted therefor:

FOURTH: I further direct that if, upon the death of my said wife, any such property herein devised or bequeathed shall remain undisposed of, then and in that event, I direct that the same shall be divided equally among my beloved sons, LOUIE BUSBY, CECIL BUSBY, JAMES BUSBY, and JERRY BUSBY, in equal parts, share and share alike. If at such time any of my said beloved sons are deceased, said deceased son's share of my estate shall be divided equally among his surviving children and surviving spouse, if any, share and share alike.

In every other respect I hereby republish my said Will.

IN WITNESS WHEREOF, I, W. A. Busby, have hereunto set my hand and affixed my seal to this First Codicil to my LAST WILL AND TESTAMENT dated August 11, 1966, on this the 23 day of June, 1986.
