AFFIDAVIT

Before me, the undersigned authority, a Notary Public in and for the aforesaid County and State, personally appeared Kate Curry, who is known to me and being by me first duly sworn deposes and says:

My name is Kate Curry and I reside in Savannah, Chatham County, Georgia. I am currently married to Bill Curry. On or about January 9, 1982, I was married to John N. Luther and my name became Kate Griffen Luther. During my marriage to John N. Luther, we were joint owners of a plot of real property in Shelby County, Alabama described as follows:

PARCEL I

Commence at the SW corner of the SW 1/4 of the NE 1/4 of Section 23, Township 19 South, Range 1 East, thence run North along the West line of said 1/4-1/4 Section 329.65 feet to the point of beginning of the parcel of land herein described; thence turn 91 deg. 14 min. 17 sec. left and run Westerly 329.30 feet, thence turn 88 deg. 47 min. 23 sec. left and run Southerly 905.44 feet to a point on the North right of way line of Old U. S. Highway No. 280; thence turn 118 deg. 52 min. 37 sec. left and run Northeasterly along said right of way line 469.69 feet; thence turn 67 deg. 58 min. 09 sec. left and run Northwesterly 690.59 feet to the point of beginning.

PARCEL II

Commence at the SW corner of the SW 1/4 of the NE 1/4 of Section 23, Township 19 South, Range 1 East; thence run North along the West line of said 1/4 1/4 Section 329.65 feet to the point of beginning of the parcel of land herein described; thence turn 88 deg. 45 min. 43 sec. right and run Easterly 561.62 feet; thence turn 88 deg. 58 min. 37 sec. right and run Southerly 424.56 feet to a point on the North right of way line of Old U. S. Highway No. 280; thence turn right 63 deg. 22 min. 23 sec. and run South Westerly along said right of way line 566.25 feet; thence turn 112 deg. 01 min. 51 sec. right and run Northwesterly 690.59 feet to the point of beginning; being situated in the SW 1/4 of the NE 1/4 and the NW 1/4 of the SE 1/4 of Section 23, Township 19 South, Range 1 East, Shelby County, Alabama.
