or desired.

(b) To operate a general service business, servicing, installing, maintaining, repairing, modifying and altering mechanical equipment of any and all kinds including the controls and any and all other parts of the same and doing and performing any and all kinds of service, maintenance, installation of any and all kinds of other equipment and related items including electrical, piping and ductwork, buying and selling at wholesale and retail, in new construction, modifying and altering and repairing in existing construction including design and engineering and doing any and all other things that may be required or related or being appropriate to this type of business.

To buy, sell, rent or otherwise acquire any and all types of equipment, tools or other instruments generally used in the construction business, including but not limited to vehicles, heavy equipment or any other instrument or device generally used therein.

(c) The transaction of any and all lawful business for which corporations may be incorporated in this state.

#### ARTICLE IV
