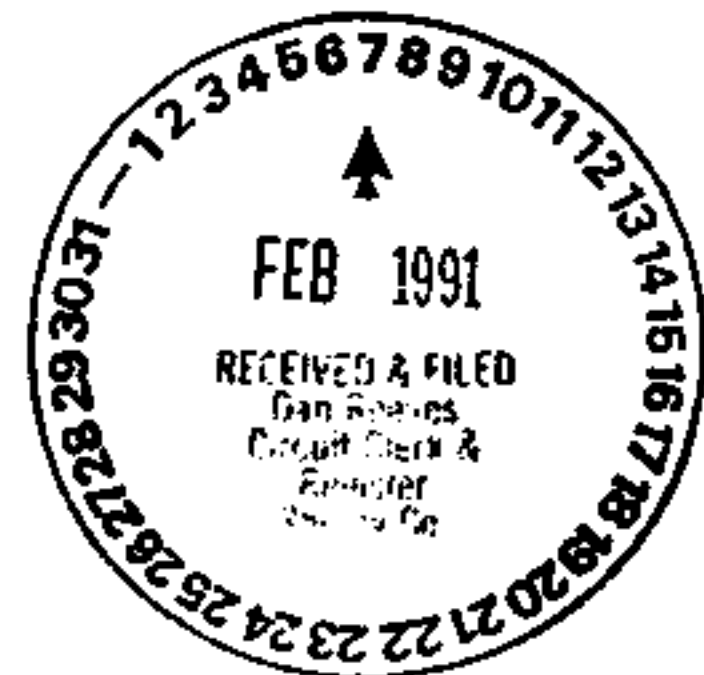

Johnson and Mildred M. Johnson as against Stewart R. Dudley and Parkview Forest Products, Inc., and upon consideration thereof, it is hereby ORDERED, ADJUDGED and DECREED by this Court as follows:

1. The Plaintiff's Complaint and Amended Complaints against all Defendants in this action are dismissed with prejudice;
