in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned hereby

releases, quitclaims, grants, sells, and conveys to Clyde M. Wyatt and
Margaret Louise Wyatt

(hereinafter called Grantee), all our right, title, interest, and claim in or to the following described real

estate, situated in Shelby County, Alabama, to-wit:
Commence at the SW corner of Section 28, Township 19 South, Range 2
East, and then run East along the South line of said Section a dis-
tance of 2,518.2 feet to a point; thence turn an angle to the left
of 89°44'41" and run a distance of 820.2 feet to a point on the
North right of way line of U.S. Highway 280, said point being iden-
tified as "POINT A"; thence continue along last described course a
distance of 274.5 feet to a point; thence turn an angle of 103° 23'09"
to the right and run a distance of 25 feet to the point of beginning
of the property herein conveyed; thence continue along last described

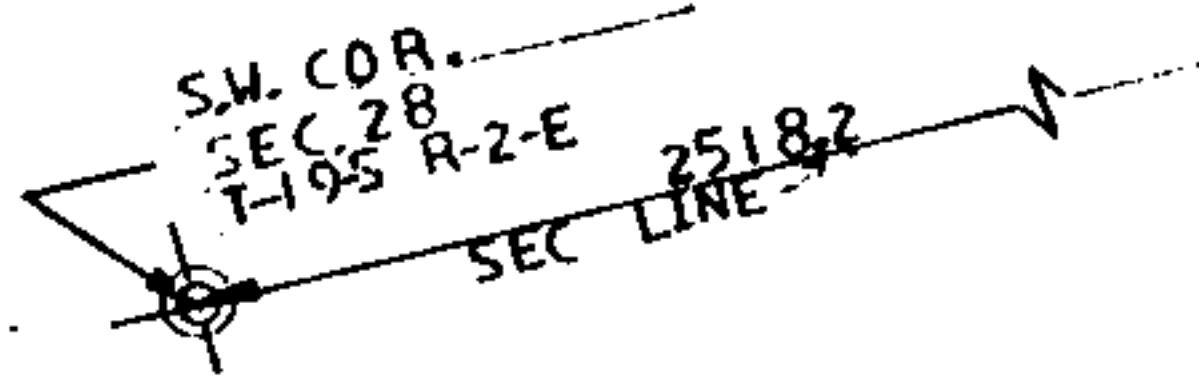
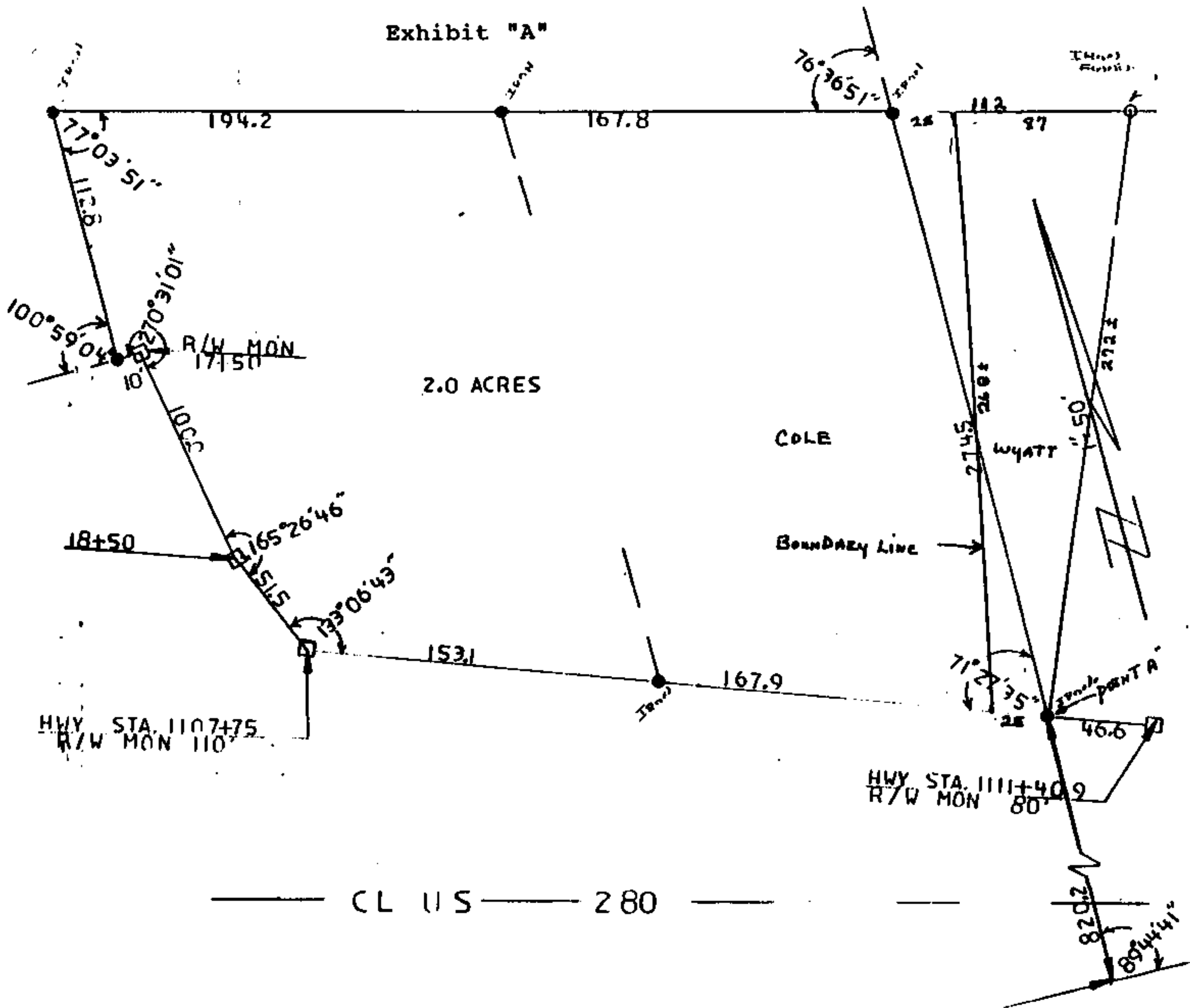
