

GENERAL POWER OF ATTORNEY

KNOW ALL; MEN BY THESE PRESENTS, that I, **MARIE FURBISH CLARK**, of Shelby County, Alabama, do hereby make, publish, constitute and appoint my daughter, **JANICE CLARK POPE**, my true and lawful attorney-in-fact for me and in my name, place and stead and on my behalf for my use and benefit to do any and all things that may lawfully be done by an attorney-in-fact, including, but not limited to, the following:

1. To receive and disburse monies (including amounts on deposit in checking and savings accounts), collect and assemble securities, notes receivable, certificates of deposit, and property and interests in property of all kinds and descriptions;
2. To have access to any safe deposit boxes, security vaults, and the like;
3. To sell or convey real or personal property in fee simple or otherwise by deed or other instrument upon such terms and conditions, including credit, as said attorney shall deem fit;
4. To sign state, federal or other tax returns as may be required on my behalf;
5. In general, to do and perform all acts and things which may be lawfully done by an attorney-in-fact.

I hereby ratify and affirm the lawful acts of my attorney-in-fact done pursuant to the powers herein conferred upon such attorney-in-fact.

This power of attorney shall remain in full force and effect until the same shall have been revoked by written notice duly recorded in the Register's Office of Shelby County, Alabama, or until expiration by operation of law, it being intended that this power of attorney shall remain effective even in the event of mental or physical debility on my part.
