DECLARATION OF UNIT

WHEREAS, the undersigned, having full authority in and under the oil, Gas and Mineral Leases described in Exhibit "A" with reference to the lands described in said leases and embraced within the following described unit, consider it necessary and advisable to pool, consolidate and combine the lands covered by said leases situated in said unit in order to properly develop said land and leases, to promote and conserve occluded natural gas and coal bed methane in order to comply with orders prescribed by the Oil and Gas Board of Alabama and to establish as an occluded natural gas and coal bed methane drilling, operating and producing unit the land hereinbelow described;

NOW, THEREFORE, in accordance with the power and authority granted by leases described in Exhibit "A" and in consideration of the premises, the undersigned do hereby pool, combine and consolidate the Oil, Gas and Mineral Leases and interest described in Exhibit "A", and the lands and acreage covered thereby so as to constitute and establish the following described lands as a drilling, operating and production unit for the development, production and transportation of occluded natural gas and coal bed methane, to wit:

Permit No. 6727-C of the State Oil and Gas Board of Alabama.

There is hereby pooled and combined, into the area described above, all the leasehold, mineral, overriding royalty and royalty interest and all other interest in the above described unit as to which the undersigned (or any of the undersigned) have the right to pool and combine into the unit created hereby whether or not said leases and other interests are particularly described herein. Said unit is subject to the rules, regulations and orders of the Oil and Gas Board of Alabama, and the above described lands have been established as a gas unit by Order of the State Oil and Gas Board of Alabama for the SEGCO 30-2-110 well.

The pooled unit so created shall remain in force until:

- Dissolved by written instrument executed by all of the (a) undersigned or their successors in interest, or
- The leases described in Exhibit "A" have terminated (b) by their own terms and provisions, or
- Superseded, as to any pool or pools, which shall occur (C) whenever the Regulatory Agency having jurisdiction prescribes a spacing pattern different from that under which the unit hereby created was formed, which different spacing pattern is applicable to any such pool or pools and pursuant to which revised pattern a different unit has been established with respect to such pool or pools.
