WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS THAT in consideration of Twenty-five Thousand, Nine Hundred and No/100 (\$25,900.00) Dollars to the undersigned grantor, WINDY OAKS (hereinafter sometimes referred to as "Grantor"), an Alabama Partnership composed of Shelby Homes, Inc. and Roy Martin Construction, Inc., in hand paid by Michael R. Allen and Marcia J. Allen (hereinafter sometimes referred to as "Grantees"), the receipt whereof is hereby acknowledged, Grantor does by these presents, grant, bargain, sell and convey unto Grantees, as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:
