SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT IS BEING RE-RECORDED TO CORRECT THE LENDERS NAME FROM SOUTHERN CAPITAL RESOURCES, INC. TO First National Bank of Gainesville dba The STATE OF ALABAMA Mortgage Source.

COUNTY OF SHELBY

This Subordination Agreement, made and entered into this the 26th day of November, 1991, by and between Southtrust Bank of Alabama, N.A., as Party of the First Part, and First National Bank of Gainesville dba The Mortgage Source Party of the Second Part.

WITNESSETH

THAT, WHEREAS, Jimmy L. Patrick and Demetra J. Patrick has/have an outstanding lien in favor of Southtrust Bank of Alabama, N.A., dated November 9, 1989 and recorded in the Probate Office of Shelby County, Alabama, in Book 270, page 589-592 on certain real estate described therein to secure an indebtedness of \$12,000.00, and said lien is in full force and effect; and,

WHEREAS, Jimmy L. Patrick and Demetra J. Patrick has/have made an application to the Party of the Second Part for a loan in the sum of \$73,000.00 and said Party of the Second Part is willing to make said loan to the said Jimmy L. Patrick and Demetra J. Patrick, provided they furnish it with a mortgage on the lands described in the aforesaid lien, and the said Southtrust Bank of Alabama, N.A. subordinate the above described lien and make the same second and subservient to the mortgage of First National Bank of Gainesville dba The Mortgage Source; and

WHEREAS, the said Party of the First Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Party of the Second Part as an inducement to it to make said loan.

NOW THEREFORE, in consideration of the premises and the further consideration of the sum of \$ -0-, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of Jimmy L. Patrick and Demetra J. Patrick to Southtrust Bank of Alabama, N.A., dated November 9, 1989 and recorded in the Probate Office of Shelby County, Alabama in Book 270, page 589-592, shall be second and subservient to the mortgage of Jimmy L. Patrick and Demetra J. Patrick to First National Bank of Gainesville dba The Mortgage Source, dated November 26, 1991 and recorded in the Probate Office of Shelby County, Alabama in Volume Page to secure the sum of \$73,000.00, plus interest on the land described therein, and the said lien of the said Southtrust Bank of Alabama, N.A. shall be subordinate to the mortgage of First National Bank of Gainesville dba The Mortgage Source.

IT IS FURTHER agreed that should Jimmy L. Patrick and Demetra J. Patrick default in his/her/their payments under the terms of the real estate mortgage to First National Bank of Gainesville dba The Mortgage Source the said First National Bank of Gainesville dba The Mortgage Source agrees to notify SouthTrust Bank Of Al., N.A., P.O. Box 531150, B'Ham., AL 35253 of said default prior to taking legal action.
