) MODIFICATION OF MORTGAGE  
) AND SECURITY AGREEMENT

THIS MODIFICATION OF MORTGAGE AND SECURITY AGREEMENT (the "Agreement") is made and entered into effective as of the 18<sup>th</sup> day of February, 1992, by and between Fairway Investments, Inc., an Alabama corporation (the "MORTGAGOR"), and FLEET NATIONAL BANK, a National banking association (the "MORTGAGEE").

TO WHOM IT MAY CONCERN:

WHEREAS, Mortgagor executed for the benefit of Mortgagee a Mortgage and Security Agreement dated December 30, 1991 (the "Mortgage") to secure an indebtedness in the principal amount of Three Million Eight Hundred Thirty Four Thousand and no/100 Dollars (\$3,834,000.00) evidenced by an original promissory note dated December 30, 1991 (the "Note") and said Mortgage was recorded in Book 380 at Page 502, in the Probate Records of Shelby County; and

WHEREAS, Mortgagor has requested the consent of Mortgagee for Michael D. Thompson to transfer certain shares in the Mortgagor subject to a Shareholder's Agreement; and

WHEREAS, Mortgagee has consented to the transfer provided Mortgagor enters into this Modification;

NOW, THEREFORE, FOR VALUABLE CONSIDERATION, the Mortgage is hereby amended to add the following provisions to Article V so that each provision shall constitute an "Event of Default" under the terms of the Mortgage:

5.22. Michael D. Thompson for whatever reason no longer holds voting control of the Mortgagor.

5.23. The Shareholder's Agreement dated as of the 2nd day of January, 1992 and attached as Exhibit B to that certain letter from Fleet National Bank to Fairway Investments, Inc. dated February 7, 1992 is amended in any respect without the prior written approval of Mortgagee.

Except as herein expressly modified, the Mortgage shall remain in full force and effect as written and is enforceable in accordance with the terms and provisions thereof.
