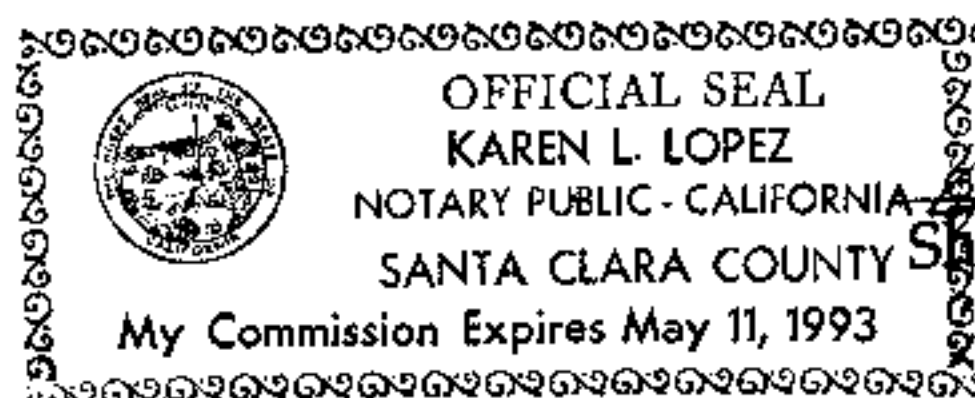
TO HAVE AND TO HOLD to the said GRANTEE, her heirs and assigns forever.

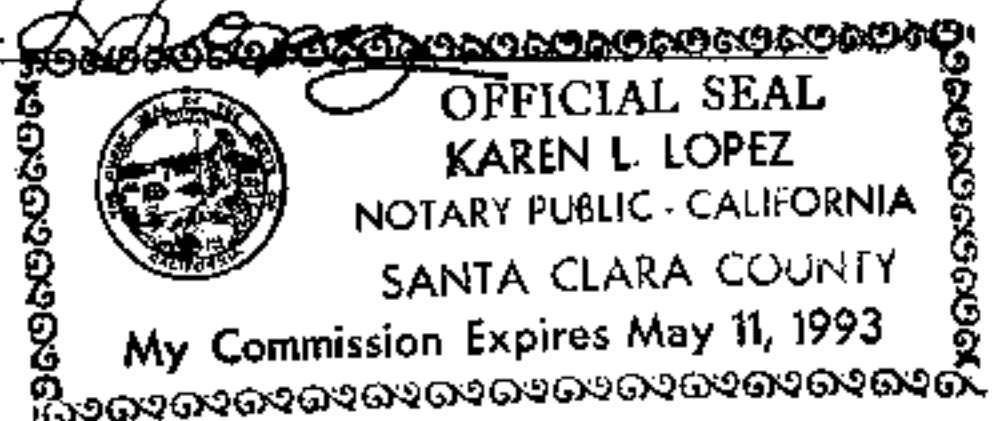
