STATEMENT OF CLAIM OF LIEN

NBC Acoustics, Inc., a Corporation, files this statement writing, verified by the oath of Brooks Lazenby, who has personal knowledge of the facts herein set forth:

1. That said NBC Acoustics, Inc., a corporation, claims a lien upon the following property, situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the Northeast Quarter of the Northeast Quarter (NE 1/4 of the NE 1/4) of Section 26, and the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section 25, all being in Township 21 South, Range 1 West, Shelby County, Alabama.

Commence at the Northeast corner of Section 26, Township 21 South, Range 1 West; thence run South 86 degrees 30 minutes 00 seconds West along the North line of said Section 26 a distance of 412.89 feet to a point; thence turn an angle to the left 89 degrees 35 minutes 00 seconds and run South 03 degrees 05 minutes 00 seconds East a distance of 596.06 feet to a point on the East right-of-way line of Main Street for the Point of Beginning; thence continue South 03 degrees 05 minutes 00 seconds East along said East right-of-way line of Main Street a distance of 267.44 feet to a point; thence turn an angle to the left 94 degrees 25 minutes 00 seconds and run North 82 degrees 30 minutes 00 seconds East a distance of 200 feet to a point; thence turn an angle to the left 85 degrees 35 minutes 00 seconds and run North 03 degrees 05 minutes 00 seconds West a distance of 13.36 feet to a point; thence turn an angle to the right 82 degrees 58 minutes 00 seconds and run North 79 degrees 53 minutes 00 seconds East a distance of 93.46 feet to a point; thence turn an angle to the right 00 degrees 11 minutes 40 seconds and run North 80 degrees 04 minutes 40 seconds East a distance of 123.8 feet to a point; thence turn an angle to the left 80 degrees 49 minutes 25 seconds and run North 00 degrees 44 minutes 45 seconds West a distance of 220.95 feet to a point; thence turn an angle to the left 93 degrees 51 minutes 43 seconds and run South 85 degrees 23 minutes 32 seconds West a distance of 75.25 feet to a point; thence turn an angle to the right 00 degrees 29 minutes 40 seconds and run South 85 degrees 53 minutes 12 seconds West a distance of 340.94 feet to a point on

the East right-of-way line of Main Street and the Point of Beginning.


2. This lien is claimed, separately and generally as to both the buildings and improvements thereon, and the said land.


